- E. Opening Comments Board and Superintendent Mr. Canan thanked the Board and Superintendent Forson for accommodating his schedule by moving the workshops around. He stated he was out of town for the hurricane but was watching very closely to what was going on in his community and was in communication with Superintendent Forson throughout the storm.

Mr. Allen expressed the importance of arts education to the growing of our society and would like to see the district add industrial arts back into the curriculum.

Mrs. Slough congratulated the finance team for their continued excellenceand stated it takes an incredible amount of work to accomplish the things their team has; we applaud you.

Mr. Mignon thanked the Superintendent and staff for the job they did with the Emergency Operation Center (EOC) during the hurricane, giving up many hours in their day into the evening hours. He also expressed his appreciation for a job well done to the staff and administration who manned the shelters during Hurricane Dorian, recognizing that it is never an easy task.

Mrs. Barrera thanked the staff and Superintendent Forson stating many people don't realize that these hurricane preparedness days become 12 hour work days and 7 days a week. It affects the district, the staff working at the shelters, and the Operations department and through all of the hard work the best of St Johns County School District is seen.

Mr. Forson expressed gratitude to Cathy Mittelstadt and Paul Rose for being the critical decision makers during the hurricane. He stated they worked tirelessly in the field, traveling to the shelters. He also stated his appreciation for the administrators and staff members who worked at the shelters for their great work.

Next, Mr. Forson shared 2 historical facts about the school district, in our 150 years celebration. The first fact was that the Central Avenue Colored School, also

known as the Excelsior High School, actually opened in 1924 to serve students in Lincolnville. The school board building was built in 1910, and the Excelsior School served students in 1924.

The second fact was that Ketterlinus High School began the first Diversified Cooperative Training program (DCT) in St. Johns County to prepare students for life after graduation, in 1939. Even, in 1939 there was a focus and understanding to help students be prepared for work outside of the school.

Mr. Forson announced that Tracy Melgard, Civics teacher at Gamble Rogers Middle School was named Florida Council for Social Studies, Dr. Theron Tremble Florida Social Studies Teacher of the Year for Middle School for this year.

Mr. Forson mentioned several consent agenda items being approved during the meeting, they were: Human Resources Department is adding 58 new substitute teachers. In the Academic and Student Support Services area the YRD agreement with the St. Augustine Police Department which is now going to serve R.B. Hunt and Ketterlinus Elementary, and the agreement with Flagler College to host the Practicum class and experiences at Webster. In the Operations we have added emergency backup generators to 3 schools. They are Mill Creek Academy, Mason Elementary, and Osceola Elementary. This project is funded through a Hazard Mitigation Grant program with 75% of the cost reimbursable to us, and the quarterly Energy Conservation Report which shows since 2008 we have had a cost avoidance of over \$53 million.
