This bid was released by the District in January 2017, requesting pricing from bidders qualified to incorporate and practice integrated pest management (IPM) procedures for control of structural and landscape pests as referenced under IPM Policy Statement by the United States Environmental Protection Agency. Multiple companies were notified of this bid through DemandStar. In addition, the District released an ad in The St. Augustine Record on three different dates. The District received one response from Florida Pest Control & Chemical Company.

Florida Pest Control & Chemical Company has been providing similar service to the District under a bid previously awarded in 2014. The rates submitted for Bid #2017-07 come in significantly less than the current rates – a decrease of over 30%.

Based on both pricing and the level of service provided in the past, I believe it is in the best interest of the District to award this bid to the sole bidder, Florida Pest Control & Chemical Company.
