Nease High School Site and Drainage Improvements Bid #2018-14

Sealed bids will be received by the **St. Johns County School Board** for the construction of **Site and Drainage Improvements at Nease High School** located in the northeastern portion of **St. Johns County, Florida**.

Work includes **retention pond expansion and relocation, construction of multipurpose fields and piping of DOT drainage ditch**.

All bids (**to include an original and one copy**) must be sealed and clearly marked on the outside "**Nease High School Site and Drainage Improvements, Bid #2018-14**".

Bids will be received in the office of the **St. Johns County School District, Facilities and Operations Office, 3740 International Golf Parkway, Suite 200, (adjacent to Mill Creek Elementary School) St. Augustine, Florida 32092** until **2:00pm** prevailing local time, **Tuesday, April 3, 2018**. Bids received after that time will not be accepted. The bids will then be opened publicly and read aloud. The successful bidder must be pre-qualified with St. Johns County School District prior to award of any contract. Bid Security in the amount of five percent (5%) of the total bid must accompany each bid in accordance with the Instruction to Bidders. No bid may be withdrawn for a period of forty-five days after the opening thereof.

The successful bidder will be required to furnish and record in the official records of the county in which the project is located a 100% Performance Bond and a 100% Labor and Material Payment Bond in the contract documents.

The **St. Johns County School Board** reserves the right to reject any and all bids, waive informalities and minor irregularities in bidding and to accept bids which are considered to be in the best interest of the System.
