NOTICE OF PROPOSED RULEMAKING

RULE TITLE: Attendance Zone Changes for 2018-2019 relating to Mill Creek Academy

PURPOSE AND EFFECT: Amendment to School Attendance Zones for the 2018-2019 School Year relating to Mill Creek Academy

SUMMARY: Pursuant to Section 120.54, Florida Statutes, this is to notify you that the St. Johns County School Board will hold a public hearing on proposed attendance zone changes. The proposed revisions amend the existing Elementary and Middle School attendance zones to create a zone for Mill Creek Academy (K-8). They are generally described below:

Mill Creek Academy (K-8) is proposed to be comprised of the following geocodes: 034102, 034103, 034104, 034107, 034110, 034111, 034115, 034117, 020108 and 020109. Collectively, these students are currently zoned to Mill Creek Elementary School, Pacetti Bay Middle School and R. J. Murray Middle School.

Pacetti Bay Middle School is proposed to be amended to exclude the following geocodes: 034102, 034103, 034104, 034110, 034111, 034115, 034117, 020108 and 020109. These students will be zoned to Mill Creek Academy.

R. J. Murray Middle School is proposed to be amended to exclude the following geocode: 034107. These students will be zoned to Mill Creek Academy.
