Dr. Joyner offered a special thank you to Tim Forson, Paul Rose, Al Pantano and Sean Prevatt for supporting eight shelters with transportion and food service for our citizens at the shelters. Dr. Joyner also thanked our principals who served as the shelter captains: Jay Willets of Pacetti Bay Middle School, Clay Carmichael of Pedro Menendez High School, Traci Hemingway of Timberlin Creek Elementary, Randy Kelley of South Woods Elementary, Nigel Pillay of Otis Mason Elementary, Tina Waldrop of Osceola Elementary, Chris Phelps of Bartram Trail High School, and Amanda Riedl of Mill Creek Elementary, were assisted by all principal and assistant principal who were available to report to our shelters. The same can be said for our maintenance coordinators and food service managers. All members of the Cabinet

provided 24-7 monitoring at the St. Johns County Emergency Operations Center, answering questions, making decisions and dispatching assistance during the entire event. Dr. Joyner presented photographs depicting all the ways in which our school district served our community during the hurricane, and stated that this was his proudest moment in his fourteen years as Superintendent. Mrs. Slough stated that she is grateful that everyone is doing well. Mrs. Barrera stated that she was very humbled by the outpouring of volunteers for the shelters.
