- 4.04 Security Update
Presented by Mr. Paul Abbatinozzi. Approximately half of the school staff have gone through Active Shooter Training with the St. Johns Sheriff's Office. Armed Security Officers are participating in a School District and SJSO training on August 8 and will be starting fulltime in school sites on August 9. The Department of Education Office of Safe Schools is currently executing a contract with a Vendor to have ForityFL up and running hopefully by the end

of the month. They are also drafting a model policy to assist with the development of threat assessment teams at school sites.

Mr. Kyle Dresback presented regarding Mental Health Update. The Youth Mental Health First Aid training will take place during the Secondary School Counselor training on August 17. Threat Assessment Teams training will be held for Principals on September 10, then this training will be rolled out to other staff.
