He will also send an update, today, through School Messenger. The initial information was posted on the district website, Friday, February 28, 2020. Mrs. Kledzik is in contact daily, with the Department of Health (DOH) and they are communicating their protocols and what steps to take. Mr. Dresback is working to make Schoology available for academic instruction, should the district need. The DOH is contacted regarding students traveling in and out of the state, and families are directed to reach out to the DOH. Academics are provided to families that contact the schools, when students have to be absent. Signage will be placed in all restrooms with information about hygiene best practices.
