- E. Opening Comments Board and Superintendent Patrick Canan mentioned back in March there was hundreds of Covid-19 cases and the state closed the schools. Today there are thousands of cases and they are wanting students and staff to go back. Decisions continue to be challenging and difficult to

navigate with many different options. We need to bring students back with utmost safety protocols in place. Our focus remains on the health and safety of our students and staff. He requested that we push the start date to school back until September 8th. This gives more time for decisions to be made and proper equipment to be placed.

Bill Mignon spoke to many concerned parents recently and agrees with Mr. Canan's request of pushing the first day of school back until late August or beginning of September. Teachers are also concerned with their duties in the classroom. Mr. Mignon believes we need to take more time for planning and training.

Kelly Barrera expressed her appreciation for her fellow board members, teachers and students' perspective regarding the request of the change to the school start date. She is not opposed, however is not ready to make a decision to move the date until more information from the CDC and DOH is out.

Tommy Allen expressed his concern with not being able to manage contact between children at school. He agreed with Mr. Canan's comments and requested moving the start date of school back to after Labor Day. This will give more time to have the correct supports in place. He appreciated the response from parents and grandparents regarding health and safety.

Bev Slough concurred with her colleagues. She shared she would appreciate moving the school start date back to August 24th as this gives more time to get ready. Mrs. Slough stated we are very much committed to have time to plan and asked Mr. Forson to explore this information and come back with a plan.

Tim Forson expressed the first week of July we had a plan we thought would be implemented but received information from the state with changes that would conflict with that plan. The environment changed so the district has purchased emergency equipment to meet those changes. We must have protocols in place to provide a safe environment for our students, staff, and teachers. We will always err on the side of precaution. He expressed that keeping the July 17th parent deadline for options of returning to school is best for our staff to make decisions. Help from the community, as a whole, is welcomed and encouraged. This is a huge task and we will continue to work together. Mr. Forson suggested that we schedule a special board meeting next week for further discussion and vote. He reiterated that if the start date of school was pushed back we would not shorten the school year; we will still make sure the correct number of days of instruction are completed. He also expressed the deadline for July 17th is important to make successful decisions.

Mr. Forson had to leave to attend another meeting but stated he would be listening to the public comments from the recording once available and Dr. Asplen would sit in for him the rest of the board meeting.
