ORDER

On Jun 17, 2025, the St. Johns County School Board conducted a public hearing on the objections of Jean Moore and Kari Gustavson to the following library books:

- a) "There's Someone Inside Your House" by Stephanie Perkins.
- b) "Monday's Not Coming" by Tiffany Jackson.
- c) "Check and Mate" by Ali Hazelwood.

More particularly, the Complainants appealed the Superintendent's decisions to retain "There's Someone Inside Your House" with access restricted to Grades 8-12, and retain the other two titles with access restricted to grades 9-12. After hearing the Complainants' presentations, District staff's response and public comment, and being further advised in the premises, the School Board voted to affirm the Superintendent's decision, with the following modifications:

- 1) "There's Someone Inside Your House" restricted to grade 12, parental consent required.
- 2) "Monday's Not Coming" restricted to grades 9-12, parental consent required.
- 3) "Check and Mate" restricted to grades 9-12, parental consent required
