

## CHAPTER 5.00 – STUDENTS

### PARENTAL ACCESS TO INFORMATION

5.24

1. Access to Instructional Materials. All instructional materials, including teacher manuals, films, tapes, or other supplementary material shall be available for inspection by the parents or guardians of the students. A request to inspect such materials should be addressed to the student's teacher or principal.
2. Limits on Surveys, Analyses and Evaluations. No student shall be required to submit to a survey, analysis, or evaluation, that reveals information concerning the following:
  - a. political affiliations or beliefs of the student or the student's parent or guardian;
  - b. mental or psychological problems of the student or the student's family;
  - c. sex behavior or attitudes;
  - d. illegal, anti-social, self-incriminating, or demeaning behavior;
  - e. critical appraisals of other individuals with whom respondents have close family relationships;
  - f. legally recognized privileged or analogous relationships, such as those of lawyers, physicians, and ministers;
  - g. religious practices, affiliations, or beliefs of the student or student's parent or guardian; or
  - h. income (other than that required by law to determine eligibility for participation in a program or for receiving financial assistance under such program);without the prior written consent of the parent, guardian, or in the case the student is an adult or emancipated minor, without the consent of the student.
3. Access to Surveys. A parent or guardian has the right to inspect a survey created by a third party before the survey is administered by a school. Such requests should be addressed to the student's teacher or principal. The teacher or principal shall promptly respond.
4. Privacy of Survey Results. The results of a survey that reveals any of the information listed in paragraph 2 shall be private and subject to the same rules and safeguards in regard to disclosure as educational records.
5. Annual Notification. At least annually at the beginning of the school year, the District shall notify parents or guardians of the provisions of this rule in the Student

6. Specific Activities. The District shall notify parents or guardians, at least annually at the beginning of the school year, of the specific or approximate dates during the school year when the following activities are scheduled, or expected to be scheduled, and shall provide parents or guardians the opportunity to opt their child out of those activities.
  - a. Activities involving the collection, disclosure, or use of personal information collected from students for the purpose of marketing or for selling that information (or otherwise providing that information to others for that purpose).
  - b. The administration of any survey containing one or more items described in paragraph 2. a.-h.
  - c. Any nonemergency, invasive physical examination or screening that is:
    - i. required as a condition of attendance;
    - ii. administered by the school and scheduled by the school in advance; and
    - iii. not necessary to protect the immediate health and safety of the student, or of other students.
7. Exceptions. The provisions of this rule are subject to the exceptions enumerated in 20 US C 1232H.
8. Delegation of Authority. The Superintendent is authorized to enact procedures and guidelines to interpret and implement this rule.
