



As of 8/21/24 – The student body includes 3,886 gifted students and 9,329 students with disabilities who have learning or intellectual disabilities, emotional/behavioral or autism spectrum disorders, speech/language, sensory, orthopedic or other health impairments and developmental delays. An additional 5,102 students receive accommodations through 504 plans.





ESE Policies and Procedures

- Required by Florida Statute to be updated every three years
- Required to receive weighted funding through the Florida Education Finance Program, (FEFP), and funds through the Individuals with Disabilities Education Act,(IDEA).
- Utilized as the basis of identification, evaluation, eligibility determination, and placement of students to receive exceptional education services

SJCSD ESE Policies and Procedures





Section 1003.57 Florida Statutes (F.S.)

Once every 3 years, each school district and school shall complete a Best Practices for Inclusive Education (BPIE) assessment **with a Florida Inclusion Network facilitator** and include the results of the BPIE assessment and all planned short-term and long-term improvement efforts in the school district's exceptional student education policies and procedures. BPIE is an internal assessment process designed to facilitate the analysis, implementation, and improvement of inclusive educational practices at the district and school team levels.

SJCSD District Best Practices in Inclusive Education (BPIE) 2023-2026

Priority Indicators 2023-2026

- District has key personnel with expertise in the **MTSS and positive behavior intervention plans (PBIP)** who provide ongoing professional learning (PL) and technical assistance (TA), to schools to ensure that **students who need them receive multi-tiered behavior supports** in the general education classrooms and natural contexts.
- Ongoing, job-embedded, collaborative PL to implement **best practice for inclusive education**, including instruction and assessment for all SWD **based on the state academic achievement standards**.
- District provides all personnel with information and resources pertaining to the use of **person first language** in all **written and verbal communications**.
