Violation #54. Garbage & refuse disposal

The dumpster drain plug is missing and trash around on the ground around the dumpster area. Install a drain plug and clean up trash around the dumpsters and keep doors closed.

Keep dumpster lids closed.

CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

Exterior doors in kitchen has a gap at the bottom of the doors. Seal the exterior doors.
