



Pre-Planning August 2021

August 6, 2021: Optional Planning Day

Instructional Personnel returning to SJCS, or Instructional Personnel who have attended the New Employee Induction Program may choose to work this day planning or preparing classrooms. This is an optional, unpaid day of work. Returning personnel earn a “flex day” if they select to work. Flex Day opportunities are optional for teachers; they do not *have* to attend. If the equivalent of a flex day is attended, teachers may choose to take off on a planning day later in the year (10/18/21, 1/5/2021, or 3/11/21).

August 9 - 13, 2021: Regularly Scheduled Pre-Planning Week

ALL Instructional **and** Non-Instructional Personnel report to work. Anyone who requests to take this time off must be approved by the principal and submit the appropriate hours via a leave request.

- All Instructional Personnel must include a minimum of four (4) blocks of planning between Aug. 9 - 13, 2021.
- August 9 is the recommended day for schools to implement official Welcome Back events.
- August 13 8:00-12:00 is the official Meet the Teacher day. No Trainings/Meetings should be scheduled during this time.

THERE IS NOT A SINGLE DAY OF INSERVICE. Various trainings are planned throughout the week in order to comply with statutory mandates, to include school-based District initiatives, and to include offerings from the Curriculum Department. Please check your school schedule and the clarifying notes below for specifics. Training sessions will be created in BusinessPlus and communicated by the group/individual facilitating or planning the learning opportunity. Participants must register and complete all tasks in order to earn inservice credit.
