Endorsement Courses

What is an Endorsement?

An Endorsement <u>is an add-on to a teaching certificate</u> that meets the requirements set forth by the State to serve a specific population of students. In Florida, the three most common Endorsements include:

ESOL

Reading

Gifted

Each course is 60 Hours (Equivalent to 3 College Credit Hours).

The entire Endorsement for each subject is 300 inservice Hours (15 College Credit Hours).

ESOL

ESOL, or English for Speakers of Other Languages, is required of any teacher of ELA. Though the full endorsement or certification is not required of ALL teachers, ALL teachers do have at least one course they must take in the state of Florida.

ESOL 5: Assessment

• The above five courses comprise the 300-Hour Endorsement.

For those who are only required to take one 60-hour course, ESOL 3 is recommended.

ESOL 6: ESOL for Administrators

- This is only for current Principals or Assistance Principals who did not fulfill at least 60 hours of one the ESOL 1-5 courses before becoming a building administrator.
- This course DOES NOT count towards Endorsement.

ESOL 7: ESOL for Counselors

- This course is only for School Counselors.
- This course DOES NOT count towards Endorsement.
- If a teacher becomes a counselor and previously took any of ESOL 1-5, they are grandfathered for this requirement.

ESOL 8: The 18-Hour Course

- This course is only for elective/resource Teachers who DO NOT teach ELA, Reading, Social Studies, Math, Science, or Computer Science.
- This course DOES NOT count towards Endorsement.

*Please note that if you choose the **ESOL Certification** pathway, you are **still required** to complete **two*** of the five **Endorsement Courses**.

*ESOL 1 and 3 are recommended

READING

Reading is required of any teacher who specifically serves the needs of struggling readers as outlined by the State (AKA Tier 3 or Code B). The teachers required to have the Reading Endorsement or Reading Certification are outlined in the District Comprehensive Reading Plan created by the Curriculum and Instruction Department.

- 2. Passing of the K-12 Reading subject area examination

GIFTED

Gifted is required of any teacher who specifically serves the needs of students labeled as gifted.
