My resume demonstrates proven skills at meeting sustainable results and outcomes targeted at improving teaching and learning within highly academic and diverse school districts. I am ready day one to support and build upon the work that has been established within St. John County School District. As a Chief Instructional Officer, I have been at the table for major decisions impacting Beaufort County School District (BCSD) and provided academic and programmatic support for 31 schools. This is exemplified as well by my involvement in working at a strategic approach for referendums, facilities development, instructional allocations and finance, to building of a five-year strategic plan in concert with key district stakeholders.

Central to my work is my core belief that public education's purpose is to lend value to its' community and students as our profession must be responsive to the economic and community demands. This approach results with boosting economic growth and building of a talented workforce and in turn provide both a quality education and financial independence for our graduates. This belief came into practice as a secondary principal, where I aligned the career technical education (CTE) programs to the needs of the job market. My current work continues to build on this practice. As I transitioned from the school site to District leadership, I have worked at aligning school programs to grow workforce needs and supported these programs through actively seeking grant funding for an estimated total award of \$31million in grants in support of academic programs and teacher development.

To obtain this, a toolbox of protocols have been put in to place that include: school site development of 90-Day Plans that are aligned to School Improvement and Title I plans; monitoring of classroom visits data to determine professional development needs; building of school accountability understanding and practice; and close monitoring of mastery of academic standards through aligned formative assessments, resulting with a tiered model of support for school-wide progress monitoring.

The above work at building academic success was accomplished twofold; by the building of a strong workforce and being a confidant to my team and school leaders. My work also defines how I have targeted initiatives that seek to improve the overall learning community with high efforts towards improving educational opportunities for all learners, adults and students. In closing, I share that I have participated in the development of strong educational foundations and growth that was exemplary within Florida and in South Carolina and look forward to the opportunity to further discuss professional growth and work to build upon the needs of St. John's community.

It is with great pleasure and highest recommendation that I'm writing on behalf of Dr. Mary Stratos who is seeking a school superintendent position.

Currently, Dr. Stratos is Chief Instructional Officer for the Beaufort County School District in South Carolina and has served admirably in this position for 5 and 1/2 years. When the Board of Education (of which I was an elected member 2017-24 and Board Chair 2019-24) hired Superintendent Dr. Frank Rodriguez in 2019 from Palm Beach County in Florida, he recruited Dr. Stratos from Palm Beach to lead the Department of Instructional Services in the Beaufort public schools.

Our enrollment is 21,000+ students from very diverse backgrounds - economically and culturally. The ethnicity of the student body is 37% white, 32% Hispanic, 24% black and 7% other. 23% of the students are English Language Learners. 58.6% of the students are at or below the Poverty Index, yet others come from very wealthy areas, e.g. Hilton Head Island. Since the student body is so diverse, high quality academic instruction for all is challenging and Dr. Stratos has led that charge with integrity, innovation and accomplishment. We successfully navigated the uncharted territory of educating students remotely during a global pandemic. Our district is now ranked among the top in the state for teacher compensation for the third year in a row. Emphasis on quality classroom instruction has resulted in improvement in students' Meet and Exceeds scores for SC Ready English Language Arts (ELA) and Math, End-of-Course exams for Algebra and Biology and meeting College or Career Readiness standards. More than one-half of our schools are ranked as Excellent or Good on the 2023-2024 SC School Report Cards. In the last few years, we have had students matriculate at the most selective colleges and universities in the nation including Dartmouth, Duke, Harvard, Massachusetts Institute of Technology and Yale.

Dr. Stratos skillfully led and oversaw the organization of 97 volunteer seven member committees to read and review each school library book challenged by two citizens for sexually explicit or inappropriate content. Over the course of eighteen months, each committee's recommendation was then presented to the Board of Education for the final determination of the book disposition. Some books were removed from circulation and dozens more were removed from the middle schools. The opt out book form for parents placing the ultimate decision making in their hands was also improved as part of this process.

Dr. Stratos is very hard-working, always responsive, highly competent and experienced, and an absolute pleasure to work with. She has a "can do" attitude but is realistic about how a problem should be approached. She relates well to others whether they are highly educated like herself, or uneducated. She is always classy, respectful, gracious and kind. Her unique and qualified skill set will be a tremendous asset as a school superintendent. I expect nothing less than her excelling in her new leadership role. We will greatly miss her expertise and guidance here in Beaufort.
