Professionally, I am convinced that my 30+ years' experience in New Jersey education and administration has uniquely prepared me for this educational endeavour. As the county continues to experience growth and expansion, I am eager to leverage my organizational effectiveness and team-building abilities, on a larger scale, to preserve tradition, advance innovation, and ensure that ALL students of St. Johns County fully participate in their individualized educational experiences.

Personally, we absolutely LOVE the community and are in the process of permanently relocating to the Nocatee/St. Augustine area. Our plan was always to establish roots in the county and join many of our relatives and friends already living the Northeastern Florida life. The possibility to soon live and work in the neighborhood is a dream come true and one that would yield positive results for many years to come.

While it is difficult to introduce one's authentic merits and accomplishments in a cover letter or resume, I have taken the time to highlight some of my achievements to obtain a more comprehensive review of my leadership.

### Personal Leadership

As Superintendent of Schools with Upper Township BOE, I fully embraced my responsibilities with the utmost level of integrity, ethics and professionalism, understanding that the position was much more important than the person serving in the role. Equally important, I helped to create a championship team atmosphere amongst all stakeholder groups, setting high expectations and holding all involved accountable for their individual actions and efforts. This approach proved invaluable as various leadership teams were created and generated authentic ownership of all programs and initiatives, leading to meaningful professional development and retention of staff.

#### Instructional Excellence and Leadership

With 16 years experience as Superintendent of Schools with Upper Township BOE, I was successful in increasing the academic opportunities for ALL learners. With assistance from our administration, the BOE, staff, students and the community, we were the first district in the region to embrace digital literacy and install instructional technologies into every instructional space throughout the district. Once operational, we were able to employ various high quality programs and initiatives that provided increased academic and social opportunities for ALL learners, improving student achievement in all content areas and creating a safe and positive learning environment for both students and staff.

### **Business, Finance and Operations**

In my role as Superintendent of Schools with Upper Township BOE, I was accountable for a wide range of organizational operations including assessment, curriculum, facilities, finance, food services, governance, human resources, professional development, public relations, student and teacher performance, and transportation. I am proud to say that we continually led the county in student achievement, transportation efficiency, and school safety, serving as the model of excellence for other districts to emulate. Additionally, we were the only district in the county to balance our annual budget despite a \$5M reduction in state aid while maintaining ALL academic programs, staffing and facility needs. Through constant analysis, data-driven decision making and input from all stakeholder groups, we were successful in improving all operational efficiencies, providing greater opportunities for staff and student success.

### **Board, Staff and Community Relations**

While serving as Superintendent of Schools with Upper Township BOE, I had the distinct privilege to work with so many people and organizations that supported our staff and students. My relationships with my staff, students, administration, the BOE, union leadership, local and state officials, and our families were built upon transparency, trust, genuine concern, and open dialogue based on factual data and intelligence. As official spokesperson of the District, I was responsible for the accurate dissemination of all school-related information and was intimately involved with all modes of communication. The most rewarding aspect of this role was the positive interactions I had with so many staff and students not only in the classroom, but also at the playgrounds, on the ball fields, at community events, in church, at the beach and of course, in Wawa. Being an active member of the community is who I am and is the most authentic way for others to witness my passion and be inspired to do the same.

Concerning size and scale, the framework of New Jersey education does not provide opportunities for a superintendent to lead large districts or any of its 21 counties as a comprehensive entity. Fortunately, this structure enabled me to wear many different hats and gain invaluable experience and insight, in great detail, in every facet of an educational system. Additionally, this format created extreme ebbs and flows in student enrollment, providing distinctive challenges in either scenario. Because of such, I had the luxury to preside over a 19% increase in a diverse student population within a five year timeframe. I also was encumbered with a 22% decrease in student enrollment over a ten year period. In both schemes, we were successful in meeting and/or exceeding all desired outcomes.

Regarding terminal degrees, most people seek a doctorate to advance knowledge in a particular field of study, enhance career prospects, and increase earning potential. While I was prepared to begin my studies at various moments in time, I made the conscious decision to place more value on gaining practical experience and take full advantage of my given opportunities. Over the course of my entire career, I have only worked in three different school districts. In less than a five year span, I evolved from classroom teacher to superintendent of schools; a testament to my loyalty, abilities and expertise. Although my title lacks post-nominal letters, I can testify that I have developed the required acumen and possess the necessary adroitness to lead your district and help transform your students into responsible, self-directed, and civic-minded citizens.

As a superintendent is charged with making the final recommendations on all potential employees, I truly appreciate your position and desire to hire the BEST FIT to meet and exceed your consolidated expectations. ## Greetings:

It is my pleasure to enthusiastically recommend Vincent Palmieri for all Superintendent positions in which he seeks. His experience, expertise, a unique ability to build a model school climate and culture and perform at the highest level when faced with crisis are just some of the reasons he will succeed anywhere.

Once I became a full-time New Jersey Education Association Director, overseeing 14 local unions in 12 school districts, I began working with two unions in the Upper Township School District, the very one led by Superintendent Palmieri. Here, working with all the teachers and educational support professionals in that District as their union leader I worked successfully daily with Palmieri. A leader's ability to navigate sometimes very sensitive issues in the Labor Management relationship is imperative to the success of the district. 
