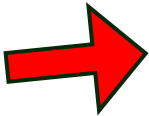

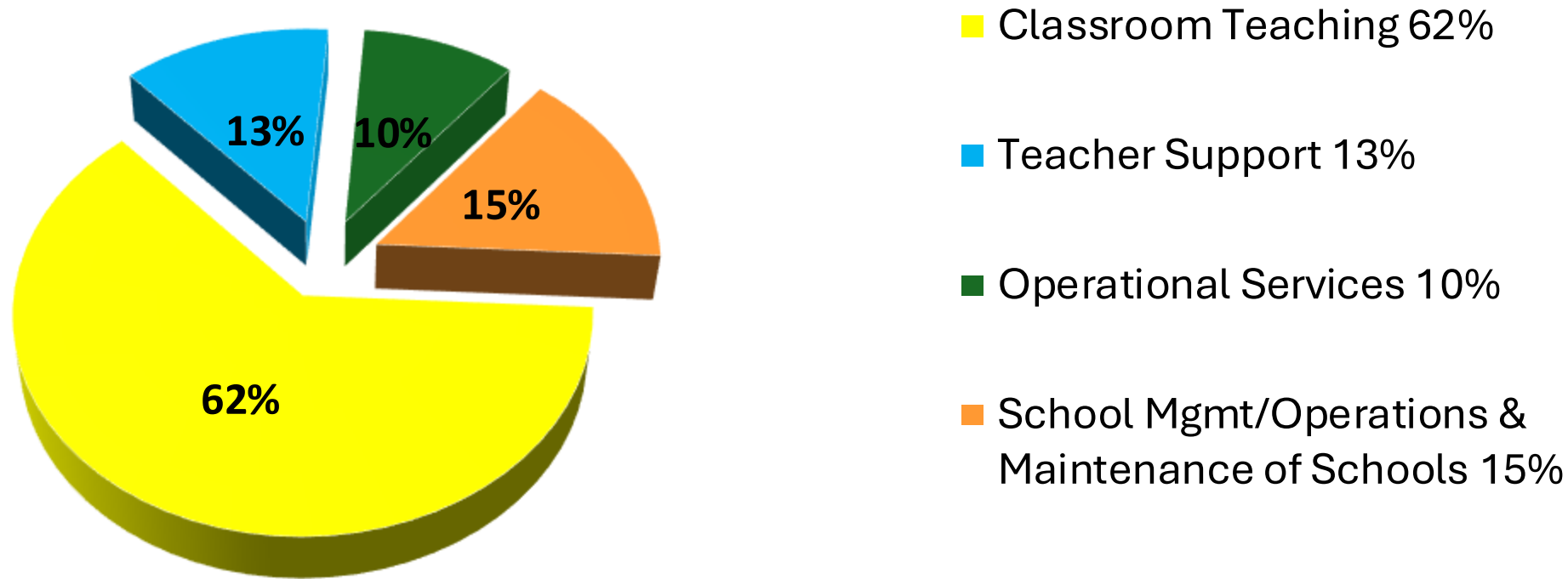

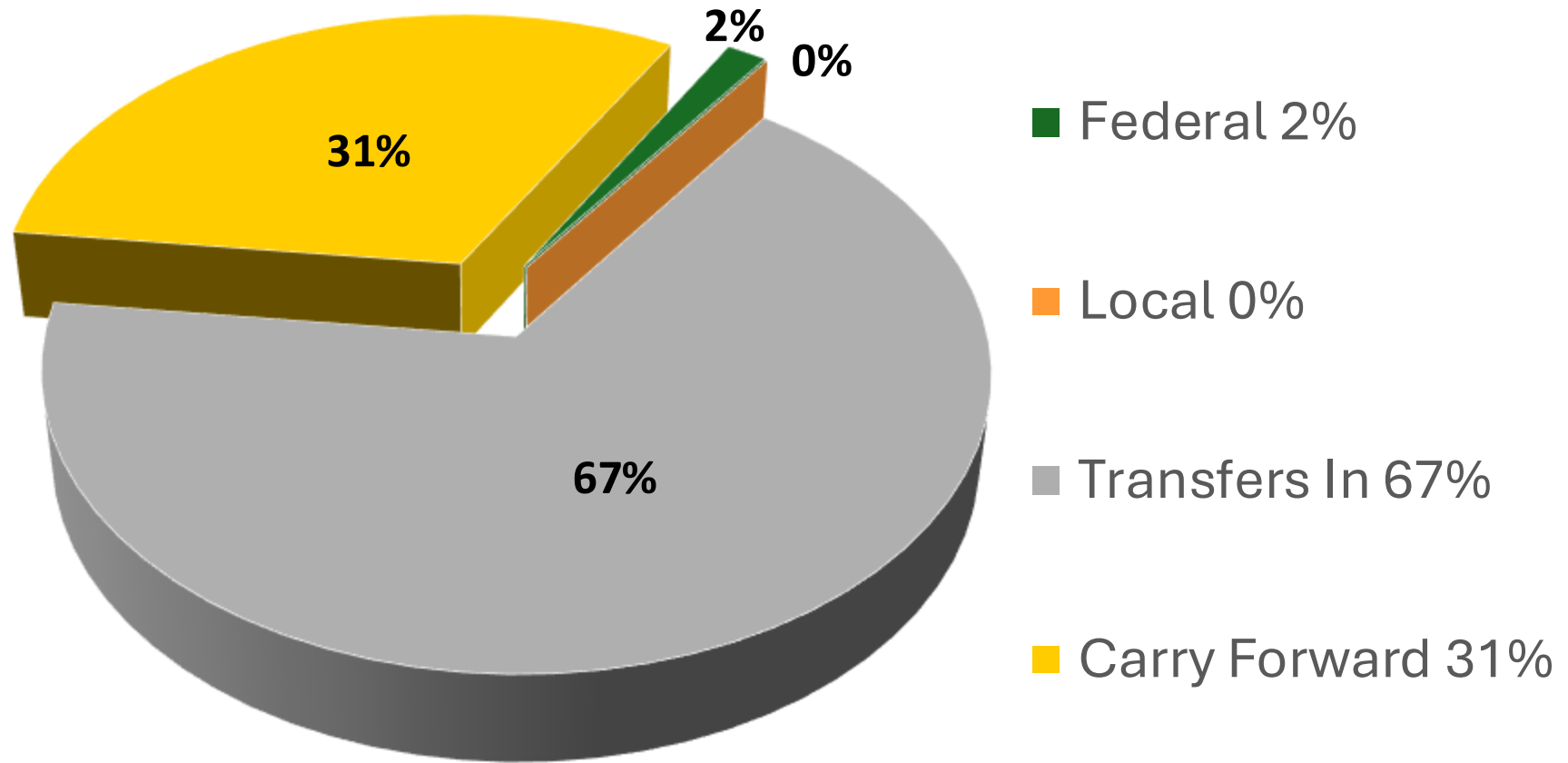


Capital Outlay Appropriations



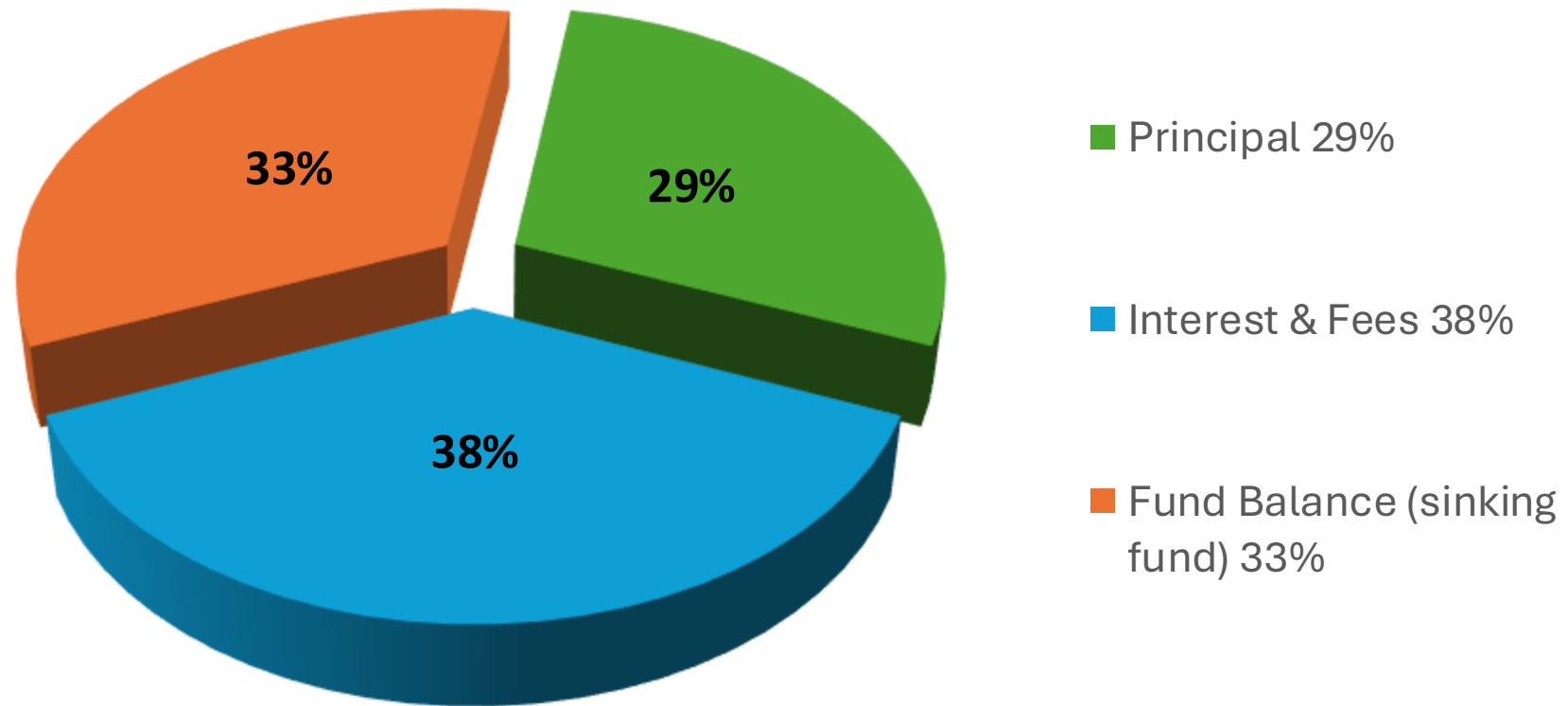


Debt Service Revenue



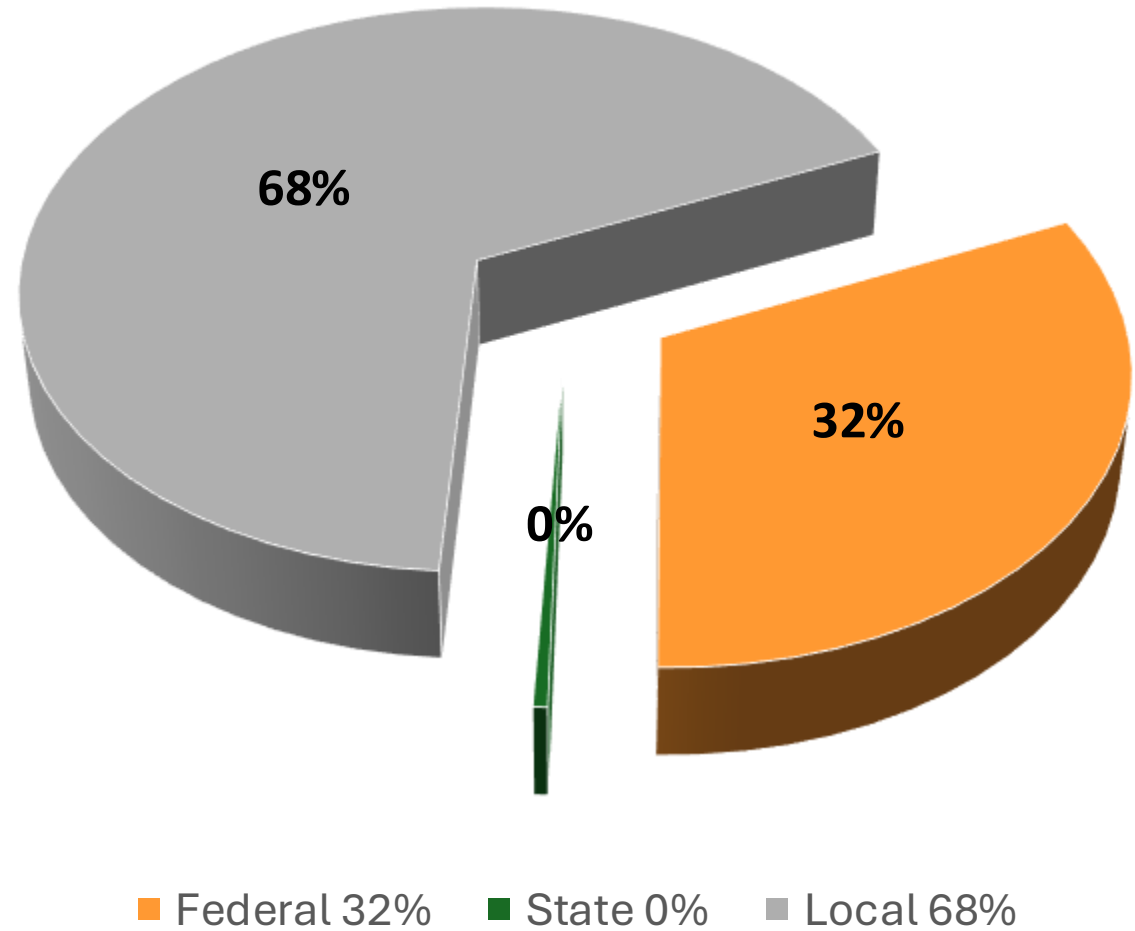


Debt Service Appropriations



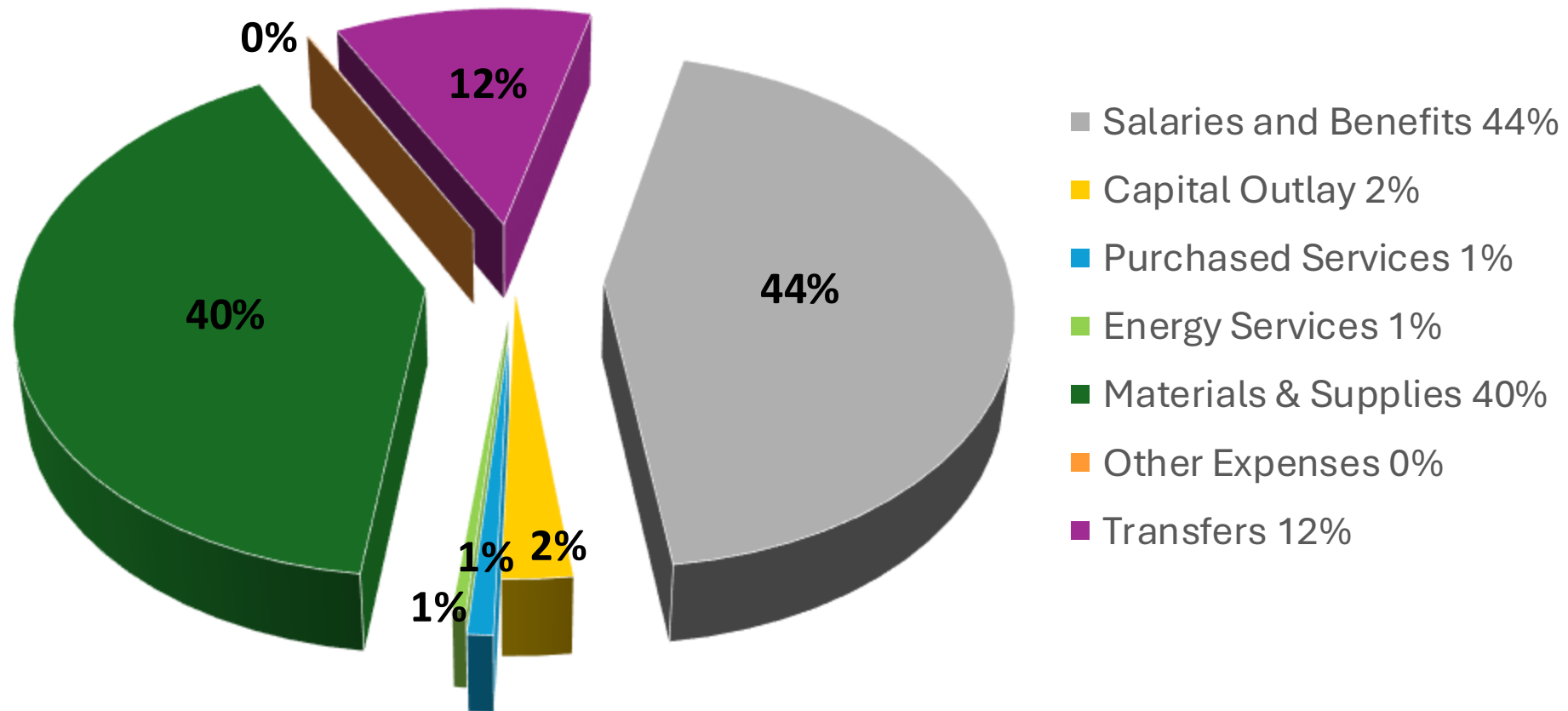


Student Food & Nutrition Services Revenue





Student Food & Nutrition Services Appropriations



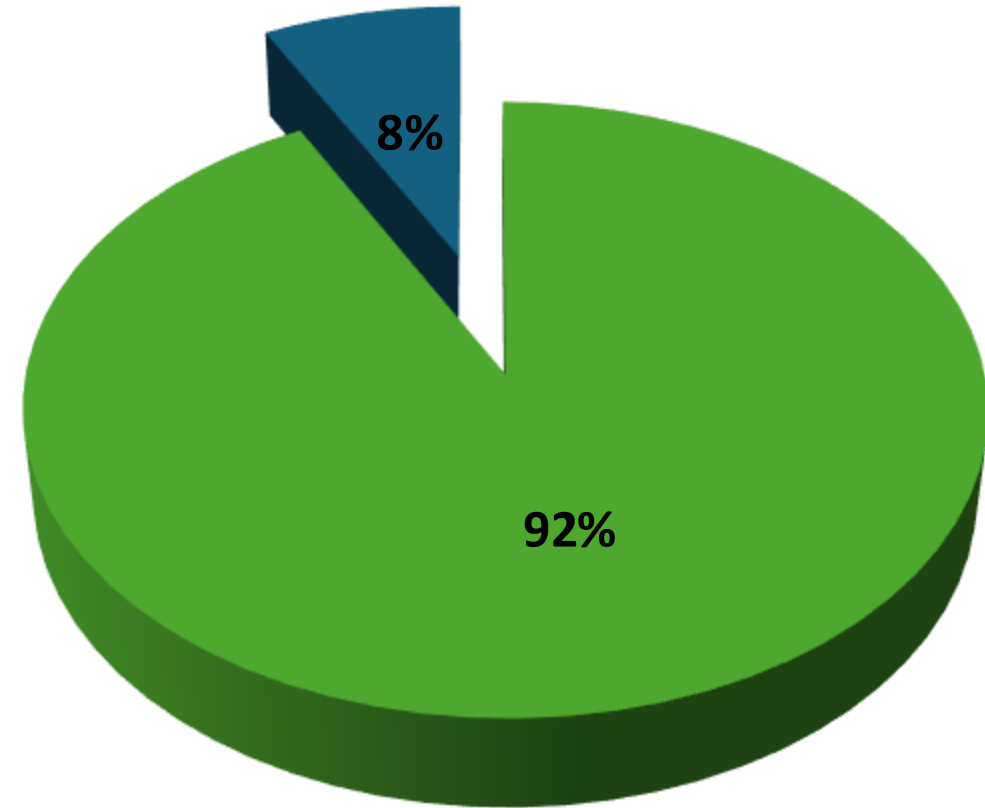
