**NOTICE OF PROPOSED RULEMAKING**

RULE TITLE: Attendance Zone Changes for 2026-2027 for K-8 Schools QQ and RR.

PURPOSE AND EFFECT: Amendment to School Attendance Zones for the 2026-2027 School Year.

SUMMARY: Pursuant to Section 120.54, Florida Statutes, this is to notify you that the St. Johns County School Board will hold a public hearing on proposed attendance zone changes. The proposed revisions amend existing Elementary and Middle School attendance zones due to the opening of new K-8 Schools QQ and RR. They are generally described below:

**K-8 School QQ**

**K-8 School QQ** is proposed to be comprised of a portion of the following Geocodes: 034117, SilverLeaf Plantation (currently zoned to Wards Creek Elementary and Pacetti Bay Middle Schools); 034111, SilverLeaf Plantation and CR 16A (currently zoned to Mill Creek Academy) and 056104, SilverLeaf Plantation (currently zoned to Trout Creek Academy). This area is comprised of the following neighborhoods: In SilverLeaf Planation -- Cherry Elm, Elm Creek, Silver Landing, Aspire, Silver Falls, Silver Meadows, Elm Ridge, Hartford Silverleaf Village, Newbrook and Parcels 14A, 22, 24, 25, 26, 29F, 38A and 38C and along CR 16A – Hammock Oaks.

**Wards Creek Elementary School** is proposed to be amended to remove portion of the following Geocodes: 034117, SilverLeaf Plantation (currently zoned to Wards Creek Elementary and Pacetti Bay Middle Schools). This area is comprised of the following neighborhoods: In SilverLeaf Planation -- Cherry Elm, Elm Creek, Silver Landing, Aspire, Silver Falls, Silver Meadows, Elm Ridge, Hartford Silverleaf Village, Newbrook and Parcels 14A, 22, 26 and 29F. The attendance zone is also proposed to be amended to add a portion of Geocode 034115, SilverLeaf Planation and CR 16A (currently zoned to Mill Creek Academy). This area is comprised of the following development parcels in SilverLeaf Plantation: 40, 41A, 41B and 42; along with Hardwood Landing Road, Hardwood Trail and Penny Brooke Lane.

**Pacetti Bay Middle School** is proposed to be amended to remove portion of the 034117 Geocodes, SilverLeaf Plantation (currently zoned to Wards Creek Elementary and Pacetti Bay Middle Schools). This area is comprised of the following neighborhoods: In SilverLeaf Planation -- Cherry Elm, Elm Creek, Silver Landing, Aspire, Silver Falls, Silver Meadows, Elm Ridge, Hartford Silverleaf Village, Newbrook and Parcels 14A, 22, 26 and 29F. The attendance zone is also proposed to be amended to add a portion of Geocode 034115, SilverLeaf Planation and CR 16A (currently zoned to Mill Creek Academy). This area is comprised of the following development parcels in SilverLeaf Plantation: 40, 41A, 41B and 42; along with Hardwood Landing Road, Hardwood Trail and Penny Brooke Lane.

**Mill Creek Academy** is proposed to be amended to remove portion of the following Geocodes: 034111, SilverLeaf Plantation and CR 16A and 034115, SilverLeaf Planation and CR 16A. This area is comprised of the following development parcels in SilverLeaf Plantation: Parcels 24, 25, 38A and 38C, 40, 41A, 41B and 42 and along CR 16A – Hammock Oaks, along with Hardwood Landing Road, Hardwood Trail and Penny Brooke Lane.

**Liberty Pines Academy** has no proposed amendments.

**Trout Creek Academy** is proposed to be amended to remove a portion of Geocode 056104 in SilverLeaf Plantation comprised of the development parcel 14A.

## **K-8 School RR**

**K-8 School RR** is proposed to be comprised of a portion of the Geocode 055102 in Nocatee comprised of the following neighborhoods: Seabrook Village, Reflections at Seabrook Village, Coral Ridge, Palm Crest, Anthem Ridge, Pioneer Village, Freedom Landing and Palmetto Cove (currently zoned to Pine Island Academy).

**Pine Island Academy** is proposed to be amended to remove a portion of Geocode 055102 in Nocatee comprised of the following neighborhoods: Seabrook Village, Reflections at Seabrook Village, Coral Ridge, Palm Crest, Anthem Ridge, Pioneer Village, Freedom Landing and Palmetto Cove.
